Social Security Myth of the Month:

I am unable to get spousal benefits through the restricted application

The Restricted Application is for Spousal Benefits Only - It's Almost Over, but not yet! A Social Security strategy that allows you to receive benefits while your own benefit continues to grow until age 70!

If you were born **before** January 2, 1954, and you are not taking your own Social Security benefits yet but have a spouse that is, you may qualify to use this strategy! You may even qualify on an ex-spouse!

This strategy allows you to receive a benefit equal to **50%** of your spouse's benefit, regardless of what age they started taking their own benefits, while your own benefit continues to grow until age 70!
